Christmas Trees and Scratby Ramp (235.12.17)

The Council agreed that the quote received to take down and remove the Christmas Trees was not needed. The Christmas trees located at All Saints Parish Hall and the Church will be taken down and removed by Cllr. Freeman, and the Christmas tree located on the Village Green will be taken down and removed by Cllr. Eagle. The Clerk is to raise an invoice for the Christmas tree donations to Mr Dyball, and the Parish Church.

The quote received from Andrew Tuddenham to clean and tidy Scratby ramp was accepted. Proposed Cllr. Freeman, seconded Cllr. Eyre – Unanimous.

Allotment and Burial Ground Hedges (236.12.17)

The Council requested quotations for one off topping and siding of the hedges at the Burial Ground and allotments, seven contractors were contacted and four provided quotations. It was agreed that the work would be awarded to Great Yarmouth Borough Services, proposed Cllr. Eyre, seconded Cllr. R. Wendt – unanimous.

Trees on Ormesby Village Green (237.12.17)

A formal application has been made by Robert Bell Tree Services to Great Yarmouth Borough Council regarding the felling of three trees, the application is still pending at present. The Council requested the Clerk contact Graham Watson at the Borough Council to determine the urgency and need for the trees to be felled.

Small Developments - Planning (238.12.17)

Following attendance at a planning presentation at Great Yarmouth Borough Council and in light of the Borough's five year housing land supply strategy, Cllr. Cheetham wanted to raise the idea of supporting small housing developments within the Parish, and to encourage smaller developers. It was agreed that Cllr. Cheetham and Eagle would attend the Community Land Trust meeting being held on Tuesday 12th December to obtain further information and report back at the next Parish Council meeting.

Memorial Bench Specifications (239.12.17)

Following the request from a member of the public about a memorial bench in honour of her late brother, it was agreed that the bench should be made from a wood plastic composite, similar to that of one already located on Scratby Green, and set upon a concrete slab. The Clerk is to notify the family.
