Public Forum (143.06.17)

Borough Councillor Cllr. Hanton

'Locally, I am dealing with an issue at California concerning the road signage and parking restrictions on the stretch if road that abuts the California Tavern. In effect, the signage and state of the lines is poor and the parking restriction is often ignored. Contacting Highways and parking enforcement about this issue.'

Ormesby recently has had a male in FIRS AVE cutting peoples lawns and charging £60 plus for the work. Can I ask that people are more vigilant at this time of year and always ask for ID and if in doubt don't agree to anything or hand over any money? If you have elderly family in the area please check on them and see if they have been subject to any rogue traders recently. We will be monitoring the village with more patrols and checks of people in the area.

Our next SNAP meeting will be on 13th Sept 2017 at 7pm. Venue is the Community Centre, Playing Field Lane, Martham. Everyone is welcome and we especially want to hear from anyone who wants to set up a neighbourhood watch. If there is someone who would like to do so let me know and I will get the engagement officer for our area to contact them with the details.

Public – A Parishioner asked if the problem of speeding was being addressed, especially on Beach Road, Scratby and Station Road, Ormesby St Margaret. The Chairman said that the Police were aware and had been carrying out speed checks but had not caught anyone as yet. Another Parishioner asked about the lack of road sweeping in the Beck Avenue area. It was decided to ask Cllr. Hanton to acquire a cleaning schedule for the Parish.

Update on Jubilee Woods (149.06.17)

Cllr. Freeman gave an update on Jubilee woods informing the Council that the Woodlands Trust were to supply 40 trees to plant in the wood. The Council are to decide on payment for any future visits from the Bure Valley Conservation Group.

Bird boxes had been put up and a Parishioner has offered to put up bat boxes. The Chairman asked Cllr. Freeman to get information about possible funding from the Conservation Trust for the Information boards and the signs for the next meeting.
