Apologies for absence (17.11.16) Apologies were received and accepted from Cllr. Fletcher and Cllrs. Reynolds and Childs

Borough Councillor

Cllr Reynolds has asked to be kept informed of any meetings regarding the ramp as he would like to be involved.

Cllr. Hanton had attended several meetings regarding police matters and informed the Parish Council that 23 Special Constables had been set up across Norfolk to deal with speeding matters and that covert cars were monitoring mobile telephone use. He added that Devolution was to be decided on 1st December and that those Councils who voted not to be included could become Associate members at a later stage. Cllr. Hanton also pointed out that the Dog Control consultation was now closed and would be implemented in April 2017

Police

There have been no significant incidents in Ormesby or Scratby since the date of the last meeting, crime remains at a normal levels for this time of year. Halloween and Bonfire night passed without incident, the two events were well policed with a large scale policing operation in place. We are continuing with our priority of ASB, Speeding and inconsiderate parking. The next SNAP meeting will be held on 20th December 2016 at All Saints Hall, Scratby at 1900hrs.

The Chairman said that he had received information that a consultation regarding the Lollypop school crossing service would be sent to the Parish Council in the near future.

Matters Arising (21.11.16)

The Clerk gave an updated on the following:

- Works to the war memorial had been accepted by the insurance company as a valid claim and the Clerk would inform the Contractor to start work as soon as the cheque was received.
- Cllr. Freeman was to answer an enquiry from GYBC regarding the proposals put forward of road names for Pointer East development.
- Works to improve the Pit would commence in two weeks
- Works to repair the Churchyard wall were expected to start on 16.11.16
- Cllrs. Green had requested the re-instatement of an arrow road marking on the bend of the road close to the Memorial Green. The Clerk informed the Council that NCC were unable to re-instate the road marking as it does not meet regulations.

To agree amount of donation to Royal British Legion for wreath (25.11.16)

Cllr. Freeman proposed that a donation of £50.00 be made to the Royal British Legion for a wreath. This was seconded by Cllr. Cheetham – unanimous

To discuss how to progress possible improvements to the ramp access on to the beach at Scratby (26.11.16)

After discussion it was agreed to arrange a meeting early in January with representatives from the Parish Council and Borough Council so as to determine ownership and responsibilities.

To receive an update on the Road Safety meeting held by Cllrs. C. Lee and Shrimplin together with representatives from Ormesby St Michael Parish Council. (26.11.16)

Cllr. Lee reported that a meeting had taken place and that the priority of the working party was to establish facts and produce a map to highlight areas of concern. This would then lead to a joint letter being sent to Norfolk County Council. Cllr. C. Lee would inform the Clerk when the matter was ready to be put back on the agenda.

To discuss to allow or not to allow Parishioners to deposit green waste over the cliff top on Scratby Green in order to curb further erosion as proposed by Cllr. R. Wendt.(27.11.16)

Due to the lack of information regarding the ownership of the beach and ramp, it was proposed that this be held over until such time that items on minute 26.11.16 were established.

To discuss if the Allotment Working Party be changed to a Committee (28.11.16)

After discussion it was agreed that an advisory working party be re-instated to include Cllr. Freeman, Shrimplin, Cheetham, B. Jones, K. Wendt and N. Lee. The Chairman asked that they set up the working party, elect a Chairman and take notes to report back to Council

To agree if any comments needed to be made to G.Y.B.C., regarding the possible removal of the phone box on North Road. (29.11.16)

It was agreed that no comments were needed as the phone box had not been used for over 12 months and was in a bad state of repair. The Clerk had requested comments from Parishioners but none had been received.

To receive an update on Jubilee Wood (30.11.16)

Cllr. Freeman reported that the Bure Valley Conservation Group had attended to continue to clear the woods and would be attending again 15th February 2017. The wood will be closed 5th – 10th December to allow works to be carried out on a number of trees as agreed by GYBC. When the account for this was received, Cllr. Freeman would send his request for payment of the expenses to date for the wood to Mr. J. Norton as previously agreed.

New trees would be planted and it was intended to form a Friends of Jubilee Wood and to obtain grants for the future upkeep. **To**

discuss if the Parish Council will accept a quote from Secret Gardens to clear and rotivate allotment plot no 24c. (31.11.16)

After discussion it was proposed that the work should not go ahead and that an attempt to let the plot be made and an incentive of two years free rent be offered to whoever took it over. Proposed Cllr. Eagle, seconded Cllr. Cheetham.
